## 1. What's New

We are pleased to announce the release of Audit International 26.2. This update primarily focuses on addressing technical debt and internal housekeeping. While this is not a major release, these improvements are essential for maintaining the software's overall stability and performance.

Fixed an issue on the dashboard where the Risk Response area's Assets, Equity and Liabilities, and Income Statement sections remained greyed out instead of blue, despite selecting various engagement profiles and successfully importing a trial balance.
